



## REGISTERED 20-YEAR LIMITED TRANSFERABLE WARRANTY

Raindrop Gutter Guard System (RGG) manufactures and warrants to the property owner that its gutter guard product will be free of material structural defects for a 20 year period under normal weathering conditions and when installed in accordance to RGG specifications. Coverage is waived or exclude if damage occurs from extreme weather condition and /or from any unforeseen natural or man-made forces not common as everyday occurrences. This warranty is limited to the terms and conditions stated herein and must be registered by either the property owner or the installer on-line at [www.RaindropGutterGuard.com](http://www.RaindropGutterGuard.com) within 30 days of the installation date. Registrant will receive an automated response to verify receipt. Projects not registered for warranty within the 30 day time frame are entitled only to a non-prorated (1) year warranty with coverage and terms being the same as stated herein. This warranty covers only products made and distributed by Raindrop Gutter Guard Systems.

**Warranty period is 20 years** from the date of the first RGG unit installed on the specified property or job site. This warranty is **TRANSFERABLE** by the original purchaser to a new owner at any time during the 20 year period. Coverage remains the same as from the original installation date and can only be transferred one time and is only valid if Raindrop is notified in the same registration manner of such property ownership transfer within 30 days of the transfer or closing date.

In the unlikely event of a claim, any claim must be submitted to RGG in writing within 30 days of the occurrence. RGG reserves the right to validate any claim in any manner they see fit and make restitution based on the results of such validation. It is sole discretion of RGG to repair, replace or provide financial restitution to satisfy the claim and will not exceed the prorated value calculated by dividing the original material cost by 240 months then multiply by the number of months remaining on the warranty after the claim date. RGG is not responsible for any property damage or personal injury either consequential or incidental damages arising from the usage or installation of any RGG product.

RGG does sell products through wholesale and retail outlets throughout the USA and therefore is limited to the knowledge of whom the final installer of its products may be, the current guttering system condition and or configuration, type of surrounding foliage, roof designs, elevation directions and a vast array of other variables that affect exterior building products and therefore it is the sole responsibility of the end user or property owner to perform due diligence on any installing contractor to obtain confidence and confirm the ability of such contractor or installer to perform proper installation of any RGG product. RGG may have knowledge of, may refer to you, or has classified a particular contractor as "approved" or "certified" of whom they may be authorized to promote and provide addition warranty coverage otherwise excluded or beyond the coverage set forth in this warranty but only upon proof of valid and written authorization from Raindrop Gutter Guard System. RGG categorized "approved" or "certified" installing contractors are independently owned and operated and RGG assumes no expressed or implied legal affiliation, control, liability, responsibility for or overseeing of the actions or operations of such companies. RGG reserves the right to change or modify their products and warranties at any time.

Though unlikely, maintenance, service and care of any RGG product may be needed to assure or maintain the products performance level at some time over a twenty year period or beyond and it is the sole responsibility of the purchaser to perform or obtain service from the installing contractor or other party capable of performing any such services.

This warranty supersedes all other prior warranties written, expressed or implied.
